

Multilingual Resources Help Families See if They Qualify for Advance Child Tax Credit Payments

Among other multilingual advance child tax credit resources, the IRS now has a Spanish-language version of its Child Tax Credit Eligibility Assistant. This tool helps families determine whether they qualify for the child tax credit and the special monthly advance payments of the credit. By answering a series of questions about themselves and their family members, a parent or other family member can quickly determine whether they qualify for the credit.

This tool may be particularly useful to families who don't normally file a federal tax return and have not yet filed a 2019 or 2020 tax return. Often, these are people who receive little or no income, including those experiencing homelessness, low-income households and other underserved groups. This tool can help them decide whether they should take the next step and register for the advance child tax credit payments.

The Child Tax Credit Eligibility Assistant does not request any personally-identifiable information for any family member. For this reason, its results are not an official IRS determination. The results are reliable, though people should consider the results preliminary, even if all their answers are accurate. The IRS does not keep the answers the user supplies, or the tool's results.

To help people understand and receive advance payments of the child tax credit, the IRS has developed materials in several languages. All tools are posted on the Advance Child Tax Credit 2021 page on IRS.gov.

Multilingual resources available on the 2021 Child Tax Credit and Advance Child Tax Credit Payments: Resources and Guidance page include:

* A step-by-step guide to using the Non-filer Sign-up Tool in Spanish, Chinese Simplified, Korean, Vietnamese, Haitian Creole and Russian.

The IRS has other tax-related tools and resources available in various languages, including information about IRS Free File in seven languages for people who may still need to file a 2020 tax return

Non-filer Sign-Up Tool

The online Non-filer Signup Tool helps eligible families who don't normally file tax returns register for the monthly advance child tax credit payments. It offers a free and easy way for eligible people who don't normally have to file taxes to provide the IRS the basic information needed – name, address, and Social Security numbers – to figure and issue Advance Child Tax Credit Payments.

This tool also helps eligible individuals who don't normally file tax returns register for the \$1,400 third round of Economic Impact Payments, also known as stimulus checks, and claim the recovery rebate credit for any amount of the first two rounds of Economic Impact Payments they may have missed.

Beware of scams

The IRS urges everyone to be on the lookout for scams related to both Advance Child Tax Credit Payments and Economic Impact Payments. Scammers often target non-English speakers and underserved commu-

Eloquent Judge

The first convicted felon from the mob that attacked the Capitol January 6 was sentenced last week to eight months in federal prison, two years' probation, and \$2,000 restitution. The criminal, a Florida crane operator who pleaded guilty to obstructing an official proceeding, said he was "truly regretful and remorseful" for his participation in the attempted coup.

In a sentencing statement so eloquent it deserves quoting at length, U.S. District Court Judge Randolph Moss referred to a picture of the guilty man standing in the Senate chamber



holding a large Trump flag and said, "The symbolism of that act is unmistakable. He was staking a claim on the floor of the United States Senate not with an American flag, but with a flag declaring his loyalty to a single individual over the nation. In that act, he captured the theft of democracy that we all witnessed that day."

Judge Moss noted that Ronald Reagan called our historic peaceful transfer of power "nothing less than a miracle" and that those who participated in the Capitol attack "at the very least tarnished that happy history." Furthermore, "It will be harder for all of us to convince our children and grandchildren that democracy stands as the immutable foundation of this nation. It means that we are now all fearful about the next attack in a way that we never were. It makes us question whether our democracy is less secure than what we previously believed just seven months ago. Those are all enormous harms that were caused by the events of that day," and the damage the mob caused "will persist in this country for several decades."

The man sentenced is among more than 500 charged with federal crimes connected to the January 6 events. More are being tracked down, and more charges are likely. Judge Moss specified that this first sentence was not as severe as it could have been because the convicted man did no physical damage or violence, played no leadership role, had no prior record, and promptly admitted his guilt. The judge stressed that the sentence was not a precedent for others convicted of felonies.

Don't Trash Your Mask

We're going back to masks in public places because much of the country has not yet reached the 70-80 percent vaccination rate that achieves herd immunity; we're 51 percent fully vaccinated. Not surprisingly, the pandemic is roaring back. New cases have more than tripled during the past two weeks, virtually all of them in the unvaccinated including many in their 20s and 30s. The average age of hospitalized cases in Kansas City last week was 37. Fewer than a third of 12- to 18-year-olds are fully vaccinated, making the opening of middle and high schools problematic.

All this is avoidable. Doctors now call it "a pandemic of the unvaccinated," and it's hitting hardest where vaccination rates are lowest, including Missouri, where its spreading to those unvaccinated nearby, including in Kansas.

The Delta variant of COVID-19 is now the most widespread and is far more contagious and severe than the earlier version. Fortunately, vaccines are highly effective against both. Unfortunately, the longer the virus is among us, the greater the chance that an even deadlier variant will evolve that may require new vaccines. If everyone gets vaccinated—now—we can save lives and avoid a lot of human and economic misery. It's time to think less about "me" and more about "we."

Traffic Tweeters: 1 in 5 Kansans **Use Social Media While Behind** The Wheel, Poll Reveals

- Almost 1 in 5 have taken a selfie while driving.
- 18% of drivers are unaware it's illegal to use a cellphone while driving.
- Infographic showing driving while using social media stats across the country.

We're used to a certain level of distraction while we're driving: listening to a podcast about serial killers or catching up with the sports news on local radio. But these kinds of things require us to be passive, and don't require our hands to leave the wheel. However, due to everyone's increased obsession with social media, it's become more common to find drivers turning to their phones while on the road - and not just at the traffic lights...

Gunther VW Fort Lauderdale commissioned a survey of 3,100 drivers and quite shockingly, found that almost 1 in 5 (19%) drivers in Kansas admit to using social media while behind the wheel (compared to a national average of 26%). More specifically, almost 1 in 5 (16%) of us have taken a selfie while driving.

Drivers in South Dakota and Rhode Island seem to be the most distracted drivers across the country with half (50%) admitting they have used social media while driving. Comparatively, only 11% of those in Arkansas say they've done so.

And what platforms are we most likely to use while driving? Over half (58%) said Facebook, which often involves reading boring status updates or scrolling through quick new snippets. 12% said Snapchat, where you watch short videos - possibly involving cats and 10% said Twitter, which involves reading a range of tweets, some which can make you laugh, some of which can make you angry. 8% said Instagram, involving scrolling through pretty images and perhaps catching up on celebrity updates. Another 8% watch longer videos on YouTube and just 4% exchange messages on WhatsApp while driving.

This all adds up to a driver's attention being severely distracted from what's going on them, and on the road ahead. And far more seriously, it turns out 1 in 5 (18%) drivers don't know it's actually illegal to use a cellphone while driving. When asked whether people who do this should face the same penalties as drunk drivers, almost half (48%) agreed - but worryingly, 21% of drivers said they didn't think using social media while driving affected their driving capabilities. And if a friend posted a selfie while driving, 1 in 10 (12%) people admit they would probably like the post.

'It's deeply concerning if over 1 in 4 of the driving population aren't aware of these rules of the road,' says Joseph Gunther IV from spokesperson from Gunther VW Fort Lauderdale, 'as it can have serious consequences. Being distracted by social media means you're more likely to have an accident; best to keep the updates to when you're parked up.'

Last Sunday as he was recovering from surgery for diverticulitis at Gemelli Hospital, Pope Francis went and greeted staff and other patients. The Pope then went on a balcony to speak to well-wishers that numbered in the hundreds, and to offer prayers. This is taken from the Pope's remarks that day: "I have experienced, once again, how important it is to have a good health service accessible to everyone as there is here in Italy and in other countries. A health service that is free and guarantees good service accessible to all." "This precious good must not be lost. It must be maintained, and everyone should be committed to this because everyone needs it."

Health Care for all as with Obamacare, a Universal Health Care system. Pope Francis criticized Church-run hospitals: "Your vocation as a Church is not to have money but to be of service, and that service should always be free." The Pope denounced economic inequality; the ever-widening wealth gap in the West and what he referred to as the "idolatry of money." Pope Francis sees us all as one and that our love for each other is the basis of creating a just society. In his third encyclical letter the Pope writes, to stand in support for the just treatment of immigrants all across the globe: "Certain populist political regimes, as well as certain liberal economic approaches, maintain that an influx of migrants is to be prevented at all costs." He questioned the propriety of limiting aid to poor countries, so they hit rock bottom, then be forced to take austerity measures. "One fails to realize that behind such statements, abstract and hard to support, great number of lives are at stake. Our own days, however, seem to be showing signs of a certain regression (By forgetting lessons learned from the past, and especially after wars.)

Pope Francis' Encyclical reads in part: "Ancient conflicts thought long buried are breaking out anew, while instances of a myopic, extremist, resentful and aggressive nationalism are on the rise in some countries...And a national unity, influenced by various ideologies is creating new forms of selfishness and a loss of social order exists under the guise of defending National Interests. Once more, we are being reminded that, each generation must take up the struggles and attainments of past generations, while setting its sights even higher. Goodness, together with love, justice and solidarity, are not advanced, once and for all, they have to be realized each day. It is not possible to settle for what was achieved in the past and complacently enjoying it, as if we could somehow disregard the fact that many of our brothers and sisters still endure situations that cry out for our attention."

For those countries that lack an inclusive plan that benefits everyone, Pope Francis writes: "The best way to dominate and gain control over people is to spread despair and discouragement even under the guise of defending certain values. Today in many countries' hyperbole, extremism, and polarization have become political tools. Employing a strategy of ridicule, suspicion, fear and relentless criticism, in a variety of ways, denies the right of others to exist or to have an opinion."

Ingredients

2c + 1T Flour

2 t Baking Soda

1 T Corn Starch

1/2 t Salt

1 1/4 t Ginger

1/2 t Cinnamon

1/4 t Cloves

1/4 t Nutmeg

3/4 c Butter at room temperature

1/2 c Sugar

3/4 c Brown Sugar

1-2 T Molasses

1 Lg Egg

1 Yolk

2 t Vanilla

For rolling:

3/4 c Sugar

2 t Cinnamon

Set the oven to 350°.

Line and lightly grease or spray the cookie sheet. Combine and whisk together all the dry ingredients. In another bowl, stir the butter until creamy. Add the two sugars and stir until blended. Add the molasses, egg, egg yolk and Vanilla. Stir together well. Add the flour mixture in by thirds. Use a tablespoon sized scoop to gather the soft dough and drop in the cinnamon sugar to coat evenly.

These cookies will spread so space them at least 2" apart. Bake at 350° for 10 minutes. The house will smell like Christmas as the cookies bake! Truly, these cookies are special at any time of the year! They're a great combination of two favorite Christmas cookies, how could you go wrong? These cookies are a new favorite of mine.
