

# 100-Year-Old Tonganoxie Veteran Recalls Deadly Air Combat Over the South Pacific

Hurtling only dozens of feet above the ground at more than 300 miles per hour, George Cooper piloted his B-25 through curtains of antiaircraft fire. Japanese warships anchored in Rabaul harbor-together with gunners in the town—did their utmost to knock George and his comrades out of the sky. High above their formation, American fighter pilots tumbled through the sky in deadly dogfights with their Japanese counterparts. Fiercely burning wrecks ashore and in the harbor testified to the deadly nature of the day's combat.

George spotted a line of a dozen or so Japanese floatplanes moored just fifty feet or so from the beach. He dipped the wing of his B-25—named Jayhawk—and lined up on the enemy craft. Seconds later he mashed down on the firing button and Jayhawk's eight, forward-firing .50 caliber machine guns spat heavy, thumb-sized bullets at a rate of 100 per second. When he finished his firing pass a short time later, four of the Japanese machines were aflame and several others were missing pieces.

100-year-old Tonganoxie resident Cooper recently recounted this story and many others to writer and fellow combat aviator Jay Stout during the writing of *Jayhawk: Love, Loss, Liberation* 



and Terror Over the Pacific. "George's story is unique not only because he is one of the very last—if not the last—survivors of early air combat over the Pacific during World War II," Stout said, "but because of where he came from and what he and his family endured during the war."

Indeed, George was born in the Philippines to Lawrence Cooper, a 1907 graduate of Kansas University, and Prisca Cooper, a Filipina from a well-to-do and landed family. "My grandmother had watched KU being built," said Cooper, "and vowed that her children would study there some day. And my father did just that." Lawrence went to the Philippines to teach

immediately after finishing his studies in Kansas. He quickly rose to become a regional superintendent of schools, but later turned his head to business and became the head of B.F. Goodrich's activities in the Philippines.

George grew up in Manila in an affluent neighborhood that was home to many of the most important people in the archipelago. But Lawrence, George's father, never lost touch with the values he had learned while growing up on the prairie outside Peabody, Kansas. "And he instilled that Kansas spirit in me and my siblings," George said. "Always, we were reminded

# 'For the People'

One hundred years ago this month the Nineteenth Amendment gave women the right to vote, and now the Vice-Presidential candidate of the Democratic Party is a woman, only the third of a major party. While Presidential candidate Joe Biden is well known after years as a senator and one of the most active and successful vice-presidents in our history, Kamala Harris is not as well known outside California. With the election clock ticking, it's time to know her better.



Before her election to the Senate

in 2016, Harris had been district attorney of San Francisco and was in her second term as California attorney general. As AG, she came to national attention when she refused to accept a paltry \$4 billion settlement for California homeowners defrauded by America's five largest mortgage providers. She and the AGs of many other states had jointly sued for homeowner relief from illegal foreclosures, but Harris saw the proposed settlement as inadequate and forced new negotiations. In the end, she won \$20.4 billion for people of her state and forced more relief in other states as well, the second-largest fraud settlement in American history.

Harris also won billions for citizens in consumer protection cases against the for-profit Corinthian Colleges, banks, and others, in environmental cases resulting from major oil spills from ships and pipelines and from Volkswagen's cheating on their diesel car emissions systems, and in recovering money from banks that had misrepresented investments for state pension funds. She scored major victories in prosecuting drug dealers and breaking up drug cartels and initiated an agreement with Mexico to coordinate law enforcement regarding drugs, human trafficking, identity theft, and tax fraud. Earlier, as San Francisco DA, she had cut the city's school truancy in half by holding parents accountable then, as AG, extended that effort state-wide.

As a senator, Harris is known for her solid research, collegiality, and effective interrogation of committee witnesses. In hearings, she reduced former U.S. Attorney General Jeff Sessions and current AG William Barr to stammering to avoid perjuring themselves. At one point, Sessions stalled by saying her questions "make me nervous." In Brett Kavanaugh's hearing to become a Supreme Court justice, Kavanaugh, cornered, repeatedly refused to answer a Harris question. She also criticized his skimpy FBI investigation. And she didn't go after only Republicans, being one of the first to call for influential Democrat Al Franken's resignation from the Senate because of alleged sexual harassment. That's equal-opportunity justice.

A century ago, legendary Supreme Court Justice Oliver Wendell Holmes, Jr., said the then young Franklin Roosevelt had "a second-rate intellect but a first-rate temperament." That temperament allowed FDR to become the most successful president of the past century. Harris clearly has a first-rate temperament *and* a first-rate intellect making her a worthy running mate to Mr. Biden, whose positive, empathetic temperament has been his hallmark during decades of public service. (Justice Holmes also said, "I like to pay taxes. With them, I buy civilization." Biden understands this and intends to see that corporations and the rich pay their fair share.)

In her acceptance speech, Senator Harris said that one of her proudest moments was the first time she rose in court to represent the public and made the traditional introductory statement, "Kamala Harris, for the People." That's what public service is about.

that he expected us to travel to Kansas when we came of age, so that we could attend KU."

George, who had been born when Woodrow Wilson was president, made his way to the States as a deckhand in 1940. It was while he was working to make enough money to pay for tuition that he joined the United States Army Air Forces in December 1941, immediately after the Japanese sneak attack on Pearl Harbor. He went straight into pilot training

By the summer of 1943, George was in New Guinea with the 345th Bomb Group. He was part of many of the most fearsome raids in the war and suffered the loss of many friends. At the same time, he lived in total ignorance and fear of what had happened to his family and friends in the Philippines. He had no idea if they were even alive.

By the end of the war he was in command of a bomb squadron based on Okinawa, south of Japan. As it developed his family survived both isolation and imprisonment. And they were eager to meet the wife he had married in



the States, and his new daughter.

It wasn't until after the war that George realized his dream of attending Kansas University. He graduated with a B.S. in Mechanical Engineering in 1949, and has spent the rest of his life in his beloved Kansas. And it's been a very happy and successful one he retired as a colonel with the



Air Force Reserve, and as a Vice President with Puritan-Bennett, a leader in respiratory products. More importantly, he and his wife Ruth, created a legacy that included six children, 15 grand-children, 2 great-grandchildren, and four, great-great-grandchildren. Many of them are KU alums.

is due to what I learned and what I became during World War II," George said. "So much was influenced by my experiences not only in combat, but in learning how to be a good follower and a good leader. And that has been useful ever since I came to Kansas."

# Fire Station 12 in Kansas City, Kansas Open for Service

Unified Government and Kansas City, Kansas Fire Department officials held a ribbon cutting ceremony, to officially open the Department's newest Fire Station. Fire Station #12, located at 2913 Hutton Road in Kansas City, Kansas, is now officially open to serve and protect the

"The opening of Fire Station #12 continues our commitment and focus on providing quality, responsive public safety throughout the entire community," said Mayor/ CEO David Alvey. "This new state-of-the-art facility will expand overall service and readiness in this area, improving service for nearly 2,000 additional rooftops, enhance firefighter safety which remains a critical priority, and provide expanded protection for the community as a whole."

"My chief concern as Commissioner has always been to increase public safety, and I'm proud to say, that after a long time coming, we have a new Fire Station," said District 5 Commissioner Mike Kane. "This new station will

improve service and safety for nearly 2,000 rooftops."

The new station will cover 1,939 rooftops in a 4-minute travel time that were not previously covered before the opening of Station 12.

"This fire station represents our dedication to improving overall readiness and enhancing firefighter and public health and safety in Wyandotte County," said Kansas City, Kansas Fire Department Chief Michael Callahan during his remarks at the ceremony. "Fire Station #12 will better meet the needs of Western Wyandotte County residents in terms of response time and having adequate staff in the areas where they are needed most."

The new Fire Station features ten bedrooms, six bathrooms, and a full kitchen. In addition, in an effort to make the building as energy efficient as possible, the building has LED lighting and a state of the art HVAC system.

Many of the features of this building are focused on protecting the health and safety of the firefighters who will work there. Some of these

features include:

- Cancer Prevention Initiative features include a separate locker room, DECON shower rooms, and an extractor/dryer room for cleaning firefighter bunker gear.
- Each firefighter will have two sets of bunker gear, two protective hoods, and a self-contained bunker gear carry bags
- All bunker gear lockers are ventilated.

The Unified Government chose to build Fire Station 12 at the 2913 Hutton Road location for several reasons:

- Having a station at this location increases the Department's ability to respond within four minutes to many existing commercial and retail locations in Western Wyandotte County.
- This location provides the Department with the ability to respond within four minutes to existing gaps in its Area of Response, without leaving underserved areas behind.
- · Utilizing this location now makes sense in terms of the population growth pattern of the County, leaving other options open when planning



additional stations to meet Department. For example: future demands.

"I'm proud to serve with a Commission that has chosen to face up to the hard reality that we must build public safety infrastructure where it's needed, and also to rebuild our older safety infrastructure, which we also have plans to commence immediately," said At-Large District 1 Commissioner Melissa Bynum.

In addition to providing new facilities such as the new Fire Station # 12, the Unified Government is working hard to update and maintain other fire department facilities and provide more and better equipment throughout the

- Over the past 2 years, the Department has purchased 7 pumpers (with 2 more ordered for the end of 2020), 4 trucks, and 2 ambulances (with 2 more ordered for the end of 2020).
- Increased the Area of Response (AOR) covered by four-minute and eight-minute response times in the city.
- Initiated the first-ever mutual/auto aid agreements with neighboring jurisdictions for supplemented response when needed.
- The Department has initiated the first-ever inter-

departmental training with neighboring jurisdictions for collaborative instruction.

- Equipped each firefighter with an integrated, personal Thermal Imaging Camera.
- Equipped all Truck Companies with e-DRAULIC extrication tools.
- · Providing robust and recurrent training on emerging Fire Service trends.
- Increased the number of KCKFD personnel responding to every type of alarm.

To further enhance public safety, Callahan said the Department is looking to add 18 new firefighters through a SAFER Grant. The benefits of these additional personnel would be:

- The additional personnel would be used to convert six of the Department's current three-man firefighter pumper units into four-person units.
- This conversion will allow for a more robust and rapid capability to initiate suppression, extinguishment and rescue operations.
- This would allow the Department to confirm with the NFPA 1710 Standard for the arrival of a Fire Company within four minutes, as well as the Standard to place four firefighters on the scene within four minutes.
- This would also comply with the OSHA regulation of 2 in/2 out at a fire scene.

These are the kinds of continuous improvements we are focused on, right now, and in the future," said Callahan. "While I'm proud of the improvements we've achieved, I'm also very proud of how rigorously we've worked to do this while stewarding our budget dollars very carefully.'

Callahan outlined several fiscal improvements that have been made during his tenure, including:

- Implementing Telestaff, an automated manpower program to streamline and more efficiently manage the daily staffing and overtime operations of the Department.
- Implementing a cyclical apparatus replacement program to ensure greater compliance with NFPA 1901 guidance, and reduce repair and maintenance costs.
- Implementing a lease/ turn-in program for fire apparatus to rotate the apparatus that have the highest call volume, reducing repair and maintenance costs.
- By purchasing a new pumper type, the Department saved taxpayers more than \$200,000 per pumper (approximately \$800.000 total savings.)

"I want to applaud all of the Unified Government and Kansas City, Kansas Fire Department staff who have worked to hard to achieve these objectives," said Callahan. "By increasing public safety, we improve the quality of life for all Wyandotte County residents and for our Fire Department staff. On behalf of the entire Kansas City, Kansas Fire Department, we're proud to be a part of this community, and we look forward to serving and protecting the residents of Western Wyandotte County with this new facility."

# Trump Adviser Steve Bannon, In Federal Custody, Handcuffed!

All four defendants are charged with one count of conspiracy to commit wire fraud and one count of conspiracy to commit money laundering. Each charge carries a maximum penalty of 20 years in prison.

For anyone who is keeping count of Trump's "Best People," Bannon is #6 of Trump's Senior aides who have been indicted. The others: Paul

Manafort, Rick Gates, Micheal Cohen, Roger Stone and Michael Flynn. ## **UG Unveils New Inclusive Playground**

Wyandotte County's first all-inclusive playground opened to the public on August 21, 2020. In partnership with Variety Children's Charity of Greater Kansas City and the Wyandotte County Parks Foundation, the Unified Government's Parks & Recreation Department began planning for the inclusive playground in 2015.

Inclusive playgrounds are designed to include everyone through thoughtful design, provide a safe place for children of all abilities to play together, are developmentally appropriate for children with and without disabilities, and meaningfully integrate all of the senses while encouraging social play.

Construction of the "Field of Dreams" baseball-themed inclusive park at North 126th Street in Bonner Springs began in March 2020, with the local being selected based on existing topography and the ability of existing parking to accommodate ADA vans and vehicles.

"Variety Children's Charity of Greater Kansas City is a volunteer-driven organization committed to providing children with developmental disabilities the adaptive equipment and opportunities needed for activity and inclusion," said Deborah Weibrecht, Variety KC Executive Director. "We are extremely proud of our partnership with the Unified Government and the Parks & Recreation Department's steadfast commitment to creating accessible, inclusive environments for our children to learn and play."

Some components of the new inclusive playground include wide routes for wheelchairs, flush transitions between different pieces of equipment, ADA approved swings, and unitary shock-absorbing surfacing.

The playground also includes multi-sensory play pieces to promote play experiences for all of the developing senses. The benefits of fully accessible playgrounds don't stop with kids who have challenges. Able-bodied children learn and grow on accessible playgrounds by interacting with others who are in some ways different from them. Inclusive playgrounds also allow parents and other adults with disabilities to play with their children—something that's often not possible at a traditional playground.

"Thank you to all of our partners who helped makes this playground a reality for our community. Play is a critical part of physical, emotional, mental, and social development for EVERY child, especially for children with disabilities," said Angel Obert, Unified Government Parks & Recreation Deputy Direc-

tor. "This playground is special for our community, as it allows for opportunities that kids with disabilities will now have such as being able to swing, slide and climb with their friends, something they may have never been able to do before at other playgrounds."

Although the park is now open to the public, everyone is reminded to adhere to safety guidelines, including social distancing, mask-wearing, and to be mindful of the number of children playing at once.
