Governor Kelly Announces Kansas Receives More than \$3.6M for Youth Suicide Prevention and Early Intervention

TOPEKA-Governor Laura Kelly announced today that the Kansas Department for Aging and Disability Services (KDADS) is receiving more than \$3.6 million as part of a five-year federal grant to implement youth suicide prevention and early intervention strategies. The funding will help reduce suicides and suicidal ideation in Kansans aged 10-24 years.

"Improving mental health in every community, including among our youngest Kansans, is essential to creating a healthy, thriving Kansas," Governor Laura Kelly said. "This funding will further our efforts to reduce suicide rates by providing support and resources for Kansans in crisis."

The funding for the Garrett Lee Smith State/Tribal Suicide Prevention Program Grant comes from the U.S. Department of Health and Human Services (HHS) Substance Abuse and Mental Health Services

Administration (SAMHSA). It will support KDADS in reaching young Kansans through schools, educational institutions, juvenile justice systems, substance use programs, mental health programs, and the foster care system.

"This grant funding tells young people across Kansas that 'we hear you asking for support and help, and your voices are being heard," KDADS Secretary Laura Howard said. "This federal funding allows us to implement effective programs at the local level where we can reach our younger population who are struggling with their mental health and guide them to the resources they need in their community."

The award will focus on strategies and initiatives for youth and young adults residing in Wyandotte County and the 12-county southeast region of Kansas (Allen, Bourbon, Chautauqua, Cherokee, Crawford, Elk, Greenwood, Labette, Montgomery, Neosho, Wilson, and Woodson).

"Mental health is health, and it's critical we treat it as such," Representative Sharice Davids, KS-03, said. "Through this new programming, we can help reach and educational sites; kids who are struggling and ensure they are supported and cared for. I'm proud to have helped bring these much-needed resources home to create healthy, resilient communities in Wyandotte County and across Kansas."

With this funding, KDADS will focus on addressing strategic directions identified by the National Strategy for Suicide Prevention and the recommendations created by the Kansas Governor's Mental Health Task Force (2017) and the Special Committee on Mental Health Modernization and Reform (2021-2022).

Through this award, KDADS

- Strengthen and broaden public communication efforts about risk and protective factors for suicide;
- Improve suicide risk recognition among youth organizations and professionals by increasing connections to culturally sensitive, consumer-responsive treatment services;
- Evaluate, develop, and implement evidence-based suicide screenings at behavioral health care

- Implement and enhance safety net support, including the creation of safety plans and referrals to treatment;
- Expand access to suicide post-intervention counseling by providing training;
- Improve statewide capacity to collect and analyze data related to suicide prevention efforts, and suicide morbidity/mortality.

"The award of Garrett Lee Smith funding to support suicide prevention in Kansas is recognition of the incredible work done to this point and the exciting potential for collaboration across sectors to reduce suicidality and deaths of despair in our youth," Bailey Blair, Kansas Suicide Prevention Coalition president, said. "The influx of resources combined with the infrastructure created by suicide prevention advocates and allied professionals across the state will allow for novel and responsive solutions to issues facing youth in Kansas and support the integration of suicide prevention practices across the lifespan."

What employees need to know about income tax withholding

Whether someone is entering the workforce for the first time or changing jobs, filling out new hire paperwork can feel overwhelming. One of the forms employees must complete is a W-4, Employee's Withholding Certificate. This form tells employers how much money to withhold from the employee's pay for federal income tax.

It's important for employees to know the correct amount of tax to withhold so they don't owe too much money when filing their tax return or have too much money withheld from their paychecks.

Get tax withholding right.

Federal income tax is a pay-asyou-go tax. Taxpayers pay the tax through their employers as they earn or receive income during the year. Employers take out – or withhold – income tax from employee paychecks and pay it to the IRS in the taxpayer's name.

If an employee doesn't have enough tax withheld, they may face an unexpected tax bill and a possible penalty when they file a tax return next year. If they overpay or have too much tax withheld during the year, the employee will likely get a tax refund when they file their tax return. Adjusting the tax withheld up front may mean a bigger paycheck throughout the year.

Form W-4, Employee's Withholding Certificate

New employees must complete Form W-4 so that their employer can withhold the correct amount of federal income tax from their pay. Employees should read the instructions carefully. The employer will base the amount of withholding on the information the employee provides on their W-4 and how much the employee earns.

People can also submit a new W-4 when their personal or financial situation changes and they want to update their withholding.

Taxpayers can use the Tax Withholding Estimator

If a taxpayer isn't sure how much tax they should have withheld, they can use the Tax Withholding Estimator tool on IRS.gov to:

- Estimate their federal income tax withholding.
- See how their refund, takehome pay or tax due is affected by their withholding amount.

Not all workers are employees Workers are classified as either contractors or employees according to certain rules. Workers who are independent contractors need to pay their taxes directly to the IRS. Depending on how much they earn, they may need to pay estimated tax on a quarterly basis.

Keep tax forms in a safe place. Form W-2, Wage and Tax Statement, is a taxpayer's record of the income they received throughout the year and the amount of money withheld for federal, state, local and other taxes. Employers typically send these out in late January each year. Taxpayers should keep all the tax documents they receive and store them in a safe place so they are available for filing an accurate tax return.

Bespoke Bodies" Exhibition Now Open at the National WWI Museum and Memorial

KANSAS CITY, Mo. - The National WWI Museum and Memorial will exhibit Bespoke Bodies: The Design & Craft of Prosthetics from June 2023 to April 2024 in collaboration with Design Museum Everywhere.

This major traveling exhibition explores the past, present and future of prosthetic design. Through tactile objects, interactive models and stories of designers, prosthetists and amputees, Bespoke Bodies advocates for innovations in the field that center disabled people in the design process.

The exhibition also features objects from the National WWI Museum and Memorial's collection of artifacts from the Great War. Until the First World War, most battle injuries were caused by small firearms or swords, but shrapnel from heavy artillery, machine guns and poison gas created injuries unlike those ever seen before. Out of this devastation came the urgent need for innovation in ocular, facial and limb prosthetics.

"It was a pivotal time in the field of prosthetics," said Maria Villafranca, Interim Executive Director of Design Museum Everywhere. "The artifacts provide a unique historical context to explore urgent contemporary conversations around design and disability."

"Users and prosthetists had to experiment in the past," said Matthew Naylor, President and CEO of the Museum and Memorial. "Limbs and devices went through a brief period of attempts at standardized mass production before we understood the need for a better, more bespoke future. The design and innovation of prosthetics during this time is just one of the many enduring impacts of WWI."

Visitors are invited to explore the evolution of prosthetic devices through visual stories, historical timelines and videos. These stories demonstrate that when more perspectives of people who use prostheses are part of the creation process, the better the design.

Opening on Thursday, June 8, 2023, Bespoke Bodies will be on display in the Museum and Memorial's Wylie Gallery and is presented by Bank of America.

"Bank of America is honored to partner with the National WWI

Museum and Memorial in bringing awareness of innovation in prosthetic design through this exhibition," said Matt Linski, president, Bank of America Kansas City. "As a company committed to diversity and inclusion and valuing all our differences, we're pleased to help advance the conversation around disabilities today through this educational experience."

Admission to Bespoke Bodies is \$10 for adults, \$8 for seniors and military and \$6 for youth – or just \$4 when combined with a general admission ticket. A variety of engaging programs will support the exhibition. Stay tuned to theworldwar.org for more information.

Department of Commerce Seeking Community Input for Future CDBG Projects

TOPEKA – The Kansas Department of Commerce, in partnership with the Kansas Department of Health and Environment and Kansas Housing Resources Corporation, needs input regarding how Community Development Block Grant (CDBG) funding is distributed.

CDBG funds, which are received each year from the U.S. Department of Housing and Urban Development (HUD), are used to address community needs in cities and counties across Kansas. Over the years, CDBG projects have included assistance for business startups and expansions, downtown commercial rehabilitation, housing rehabilitation, and water and sewer line extensions, among others.

The Department of Commerce wants to ensure CDBG investments advance the goals established in the Kansas Framework for Growth, the state's economic development strategic plan and are utilized more strategically to help communities across the state.

To make these changes, the Department of Commerce and its partners are seeking input from residents, local elected officials, and others via an online survey. The survey, which will take about 10 minutes to complete, will pose questions such as:

- What is the current quality of these amenities?
- How does your city or county identify what improvements are needed?
- Has your city or county benefitted from CDBG funding in the past? Responses collected are important in guiding the best way to invest in the future of Kansas. Individuals are asked to respond by Thursday, June 15.


Statement from Kansas Insurance Commissioner Vicki Schmidt:

Walmart to Build \$257M Case-Ready Beef Facility in Olathe

Walmart will build its first-ever fully owned and operated case-ready beef facility in Olathe. The retailer will invest \$257 million in the plant and create 667 new permanent jobs. Construction of the facility will also create 1,000 design, fabrication, and construction jobs.

"Thanks to our work to make Kansas a top food and agriculture state, companies continue to invest in our communities and create high-paying jobs for Kansans," Governor Laura Kelly said. "Walmart's innovative new facility will support a more prosperous future for Olathe, for the Kansas City metro, and for our state as a whole."

The opening of the 330,000-square-foot facility will further Walmart's efforts in creating an end-to-end supply chain for high-quality Angus beef while increasing transparency and capacity in its supply chain to deliver high-quality products for its customers in the Midwest.

The new facility is set to break ground later this year. The facility will be designed and built by McCownGordon Construction of Kansas City. Once opened in 2025, the facility will process Angus cuts, supplied by Sustainable Beef LLC, into case-ready beef products such as steaks and roasts to be sold in

Walmart stores across the Midwest.

Walmart first announced its ambitions to create an end-to-end supply chain for Angus beef in 2019 and has made numerous strides since then, with the opening of a case-ready beef facility in 2020 and its equity investment and long-term commercial agreement in Sustainable Beef LLC last year.

Walmart customers' shopping habits have evolved over recent years, and more customers are seeking greater transparency in the supply chain and high-quality offerings available at affordable prices. This case-ready facility will increase needed capacity in the beef industry and allow Walmart to keep up with customer demand.

"At Walmart, enhancing quality is integral to how we innovate," Walmart Senior Vice President of Deli, Meat, and Seafood David Baskin said. "Once opened, our case-ready beef facility in Olathe will mark an important next step in our journey to create an end-to-end Angus beef supply chain, ensuring our customers have access to the

high-quality meats they expect at the everyday low prices they rely on."
