Governor Kelly Welcomes Dolly Parton to Kansas for the Imagination Library Statewide Celebration

Governor Laura Kelly recently welcomed iconic singer-songwriter and early childhood literacy advocate Dolly Parton to Kansas to celebrate the statewide expansion of her Imagination Library program.

The celebration comes after the announcement last month that every child in Kansas is now eligible to participate in the program to receive one free, high-quality, age-appropriate book per month until their fifth birthday. That's a total of 60 books from birth to age 5! Today, Kansas is one of just 15 states where the program is available statewide, with more coming onboard later this year.

"Well Kansas, we did it! I'm so thankful for Governor Kelly, Representative Waymaster and the countless friends and local partners across Kansas who have made this dream come true," Dolly Parton said. "Let's celebrate by registering



"I am proud of the work our team does every day to help Kansans claim their money. While the \$400 million-returned mark is significant, we still have more than \$500 million waiting to be claimed."

Local connection with Marion County Record recalled

Several years ago when the Boss Lady and I still owned *The Wyandotte West*, we visited our friends, Bill and Joan (pronounced Joann) Meyer in the town of Marion, Kansas. It is a city of about 2,000 persons in a county of about 12,000 in the Flint Hills. We were interested in buying a new computer system that would compose newspaper pages. Bill had invited us to check out his system at the *Marion County Record*.

Bill was a professional colleague and a good friend. We served on the Board of Directors of the Kansas Press Association and the William Allen White Foundation. Bill, the long-time editor of the *Record*, believed that it was a newspaper's responsibility to have a strong editorial page. He loved the town and served several years on the Marion

School Board. Bill and I served on the Legislative Committee of the Kansas Press Association, successfully lobbying for improved laws favoring open government. He died in 2006.

Fast-forward to the present. Suddenly, Marion and its weekly newspaper were thrust into the international spotlight. The local Police Chief, Gideon Cody, a former captain with the Kansas City, Mo., Police Department, led a raid on the Record's office armed with a search warrant. The raid also included a search of the home shared by Eric Meyer and his mother Joan, co-owners of the newspaper. The police also raided the home of a member of the Marion City Council. Joan Meyer. 98, upset with the search, died the next day.

Law officers seized computers and cell phones— items that are necessary to produce a newspaper. The

blanket warrant alleged that identity theft had occurred in the process of gathering information for a story that had not been published. It concerned the issuing of a liquor license. The *Record* also did a background investigation on Cody, but did not publish anything about the research.

The Reporter's Committee for Freedom of the Press, in a letter to Cody, said "there appears to be no justification for the breath and intrusiveness of the search..." Some of the national Committee members include the Associated Press, Cable News Network, CBS News, The New York Times Company and the Society of Professional Journalists.


Tonda Rush (a Wyandotte County native), is a Washington, D.C.-based lawyer who has a long career representing newspapers with First Amendment issues, said she wasn't aware of any other such broad search

and seizure of newspapers. She discussed the 1971 *Stanford Daily* case. Police, looking for specific items, seized photos of protesting students in a 30-hour sit-in. The U.S. Supreme Court ruled that the police were within their rights to seize the photos. That ruling was the inspiration for a federal legislation that now protects the free-flow of information to journalists.

Joel Ensey, the Marion County Attorney, ruled that the Marion police did not have adequate evidence and needed to return the *Record's* equipment.

This whole experience was very stressful for Eric Meyer. But he was able to look on one brighter aspect. He has added more than 1,000 new online subscribers.

Trump responded online with yet another request to, "Please make a contribution to Donald J. Trump" posted on photo that said, "I've been indicted for the fourth time!"

Indicted four times in less than five months! It took place on a historic August night, this time in Georgia for his alleged interference in the 2020 election.

"So, what are we going to do here, folks? I only need 11,000 votes!" said Trump on a phone call recorded by Georgia Secretary of State, Brad Raffensperger.

District Attorney, Fani Willis said that Trump and the 18 co-defendants would be tried together as they were part of Trump's criminal enterprise. A total of 91 felonies were charged. Those persons who were indicted have until the 25th of August to turn themselves in voluntarily. The Fulton county jail is open 24/7 and they can arrive at anytime to be booked - to be searched, have their fingerprints taken, and mugshot photos taken. Trump will also be required to be booked and have his mugshot photo taken.

Willis had the cooperation of 30 unindicted co-conspirator individuals. It was their sworn testimonies that provided the necessary backing to the support the evidence which led the Grand Jury to recommend Indictment in a sprawling RICO case, in Georgia. Former vice-president Mike Pence said, "A gaggle of 'crackpot' lawyers have been indicted in this case." When the former president needed the best of attorneys he, instead, called on the worst.

The trial date has been set to begin in March of 2024.

Governor Kelly also declared August 14 "Imagination Library of Kansas Day." The celebration was emceed by Representative Troy Waymaster, whose three children are all enrolled in the Imagination Library Program. The evening concluded with Parton signing "Coat of Many Colors" and "Try."

"All children in Kansas should be able to have the same opportunity that my sons have," Representative Troy Waymaster said. "All three of our sons participate in the Dolly Parton Imagination Library, thank you, Dolly Parton, for providing the gift of reading for all children ages zero to five in the state of Kansas."

The National Association of Unclaimed Property Administrators estimates that nearly 33 million people in the United States have unclaimed property: financial accounts or items of value in which the owner has not initiated any activity for a number of years. When that happens, and the company cannot locate the owner, the money or properties are submitted to the state. Common examples include

unpaid life insurance benefits, forgotten bank accounts and safe deposit boxes.

Sometimes third-parties contact individuals offering to assist in filing claims for a fee. While some of these third-party "finders" are operating legally, there are also bad actors who use the promise of assistance in claiming property as a hook for scams. Johnson reminded Kansans that it is always free to search and file claims through the State Treasurer's website at https://KansasCash.ks.gov.
