

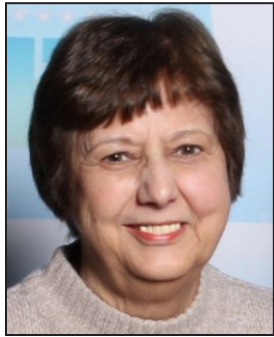

### Get Your 2023-2024 Kansas Hunting Regulations Summary, Hunting Atlas

The wait for Kansas’ top hunting-related publications is over. The Kansas Department of Wildlife and Parks has confirmed that the state’s 2023-2024 Kansas Hunting and Furharvesting Regulations Summary and 2023-2024 Kansas Hunting Atlas are available now. Both publications are free, available online at [ksoutdoors.com](http://ksoutdoors.com), and in print at nearly all license vendor locations. Hunters may also request mailed copies by calling (620) 672-5911.

The hunting regulations summary includes common rules, methods of take, season dates, bag and possession limits, as well as a list of game wardens by county, and more.

The hunting atlas includes maps of all publicly accessible hunting land in Kansas, to include Walk-in Hunting Access areas, state and federal public wildlife areas, and more. And soon, Garmin GPS and Google Earth files will be available for download, making finding a place to hunt even easier.

# Kansas Insurance Department and the Kansas Council on Economic Education mark 20 years of the Stock Market Game

Topeka, Kan. – As students across Kansas return to school, they will learn many new and valuable skills to prepare them for their lives and future careers. Financial literacy is a key part of that education, and programs like the Stock Market Game give students a great opportunity to learn about important investing principles. 2023 marks the 20th year that the Office of the Kansas Securities Commissioner, a division of the Kansas Insurance Department, and the Kansas Council on Economic

Education (KCEE) have partnered to bring the Stock Market Game to Kansas students.

“The Stock Market Game is a great program for students to learn the fundamentals of capital markets in a fun and engaging way,” said Kansas Insurance

Commissioner Vicki Schmidt. “The Office of the Kansas Securities Commissioner is proud to partner with the KCEE to bring this innovative program to classrooms across Kansas.”

For the 2022-23 academic year, over 2,400 teams totaling approximately 8,500 students from 159 schools participated in the game. In addition to learning the fundamentals of investing, students who participate in the Stock Market Game increase their performance in math, economics, and language arts while learning team-building skills. The Kansas Insurance

Department provides a grant to KCEE to fund and administer the game.

The Stock Market Game is an activity of the SIFMA Foundation, which is committed to creating a more equal society by educating young people about the importance of personal finance. The Stock Market Game originated at Buffalo State College’s Center for Economic Education in 1976. In 1977, Kansas became the second state to adopt the program. Since 2000, the KCEE has administered the game in Kansas/

## August total tax collections at \$640.1 M

TOPEKA – The State of Kansas closed August with total tax collections at \$640.1 million. That is \$24.5 million, or 3.7%, below the estimate. Total tax collections are down 1.9% from August 2022.

Individual income tax collections were \$299.3 million. That is \$25.7 million, or 7.9% below the estimate, and down 2.6% from August 2022. Corporate income tax collections were \$25.1 million, or 25.5%, higher than the estimate and up 62.3% from August 2022.

Combined retail sales and compensating use tax receipts were \$292.4 million, which is \$5.6 million, or 1.9%, below the estimate and down \$10.5 million, or 3.5%, from August 2022.

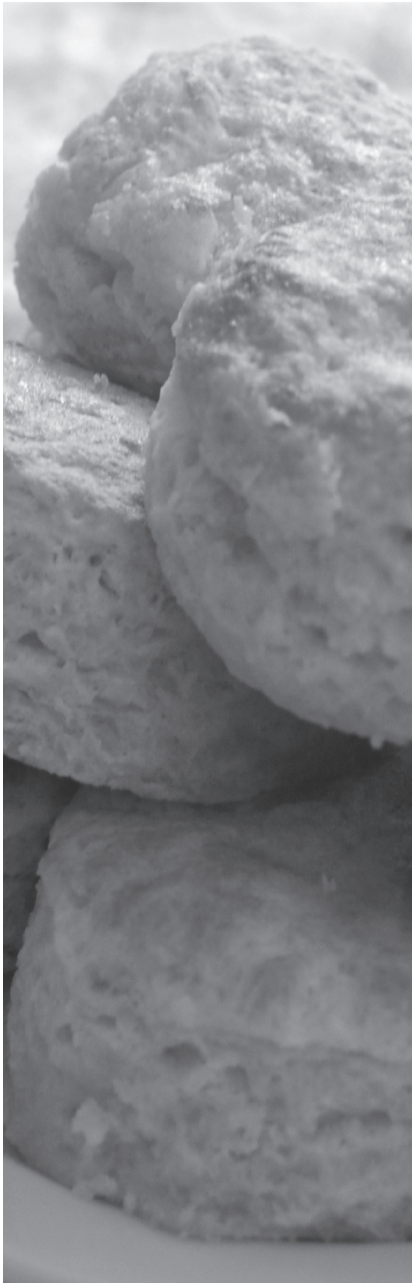

# Keeping Vital Records Safe Can Make Disaster Recovery Easier

Natural disasters can strike without warning. Sometimes even the most diligent taxpayers are left without the important personal and financial records they need. People may need documentation for tax purposes, federal or state assistance programs or insurance claims.

Here are some steps that can help them reconstruct their important records.

- Tax records
  - Taxpayers can get free federal tax return transcripts immediately using Get Transcript on IRS.gov.
  - They can also order transcripts by calling 800-908-9946 and fol-

lowing the prompts.

- People who use a tax professional to file taxes should keep their contact information in a safe place.

Financial statements  
Financial statements from credit card companies or banks are usually available online. People can also contact their bank to get paper copies of statements.

- Property records
  - Homeowners may be able to contact the title company, escrow company or bank that handled the purchase of their home or other property to get documents related to their home.



- Many property records are available online from tax assessors or other government agencies. Check local government websites for information.
- Taxpayers who made home improvements can get in touch with the contractors who did the work and ask for statements to verify the work and cost. They can also get written descriptions from friends and relatives who saw the house before and after any improvements.
- For inherited property, taxpayers can check court records for

- probate values. If a trust or estate existed, taxpayers can contact the attorney who handled the trust.
- Insurance companies often keep records related to property maintained in a home. Taxpayers should keep their property insurance contacts handy.
- Car owners can research the current fair-market value of most vehicles via resources available online and at most libraries. These include Kelley's Blue Book, the National Automobile Dealers Association and Edmunds.

## Tom's Tasty Treats

This week's recipe is a big favorite from our Southern friends and is a Springtime tradition. But, it's so scrumptious that it's something that must be made for Any occasion! A very few ingredients combine to make this and it's so easy to make! I hope you will soon try...

### KENTUCKY DERBY PIE

- Ingredients:
- 1 stick Butter, melted
  - 1 c Sugar
  - 1/2 c Flour
  - 2 lg. Eggs, lightly beaten
  - 1 t Vanilla
  - 3/4 c Pecan pieces
  - 3/4 c Chocolate chips, Semisweet or Milk
  - 1 Pie crust, readymade
- Set oven to 350°.

In the bowl of a stand mixer combine the butter, sugar, flour, eggs and Vanilla. Beat on medium speed until the sugar is dissolved, about 4 or 5 minutes. Add 1 T flour to the pecan pieces and another table-spoon flour to the chocolate chips. Add both to the filling mixture and mix in well.

Expect the mixture to be very thick. Place the filling into the raw pie shell. Bake for 30 minutes. Remove from the oven and let cool to allow the filling to firm up. Top each serving with a squirt of Redi Whip whipped cream.

Most everyone will love this pie. Maybe think about adding it to the Thanksgiving dessert table.
