How To Observe Good Neighbor Day


Being a good neighbor isn't all that difficult. Starting with kindness is always the first step.

For most of us, this sense of community is nurtured and expressed in our neighborhoods where we give each other an opportunity to share and feel part of a larger family...I call upon the people of the United States and interested groups and organizations to observe such day with appropriate ceremonies and activities."

The date changed in 2003 from the fourth Sunday in September to an annual observance on September 28th.

Child Passenger Safety Week Reminds Parents And Caregivers To Keep Kids Safe

Resources to help children travel safely by properly using car seats and restraints are available in conjunction with Child Passenger Safety Week, Sept. 17-23. This safety campaign focuses on educating the public on correct installation and use of car seats throughout the year.

The Kansas Motor Carriers Association recently donated 22 car seats to the Kansas Highway Patrol that will be distributed across the state and given to parents or caregivers in need. In addition, a National Seat Check is taking place on Saturday, Sept. 30. The Kansas Traffic Safety Resource Office urges those transporting children to visit https://ktsro.org/child-passenger-safety#station to contact the car seat check

station nearest to them for an appointment.

Motor vehicle crashes are a leading cause of death for children. According to the National Highway Traffic Safety Administration's latest research, 46% of car seats are misused. In Kansas in 2022, 16 children (ages 18 and under) died as a result of being unbelted. Common issues are children being in the wrong type of car seat for their age and size, and car seats being installed improperly, both of which leave children vulnerable to injury in a crash.

"Most parents are trying to do their best for their kids," said KTSRO Director Tenille Kimberlin, "so they may be surprised to find out their kids aren't as safe as possible in their vehicle. We want caregivers to know that it's worth finding out for sure."

Tips for parents and caregivers transporting children:

- Talk to an Expert Certified Child Passenger Safety Technicians educate parents and caregivers about the right seats for a child's age and size and how to install the seats correctly. Visit www.nhtsa.gov/equipment/carseats-and-booster-seats#installinspection to see if there is a technician available in your area.
- A Mindset Shift —Children are often moved to the next seat or position before they're ready. Review this NHTSA chart for seat recommendations https://www.nhtsa.gov/sites/nhtsa.gov/files/documents/carseat-recommen-

dations-for-children-by-age-size. pdf Once the child is ready to use a seat belt, make sure it fits correctly and that they wear it properly. The safest place for all kids under 13 is properly restrained in the back seat.

- Bigger Isn't Safer A large vehicle will not keep a child safe in a crash if he or she is not properly restrained. In 2021, more than a third (37%) of the children killed while riding in light pickup trucks were unrestrained, followed closely by SUVs (36%), passenger cars (36%), and vans (34%).

Quotes To Ponder

The Attorney General is authorized pursuant to New York Executive law €63(12) to: Bring an action to enjoin, repeated fraudulent or illegal acts" and persistent fraud or illegality in the "carrying on, conducting or transaction of business." Attorney General James has initiated a Gargantuan lawsuit which could bankrupt the Trump organization and pave the way for future criminal prosecution. After being fined \$1 Million by a federal judge tired of Trump's frivolous antics, Trump dropped his lawsuits against Attorney General James. She filed the lawsuit last September and seeks \$25 0 Million+, and she also seeks to revoke Trump's legal certificate to be able to conduct business in New York.

63(12) gives the Attorney General "plenary powers" to prosecute a case. A plenary trial is a bench trial with full blown discovery and depositions. Donald Trump received the benefit of the Attorney General's discretionary decision to begin with. Right now, there is a motion by the New York Attorney General to dispense with a trial and find as a matter of law, on the record established.

The attorney general has a very low bar to show in order to convict. She will then be able to get the "equitable relief" that she is seeking. The more than \$250Million. The "low bar" that James needs to prove in order to get a conviction is a standard of, "Is it more likely than not that fraud occurred. She doesn't have to go to "beyond a reasonable doubt," as in criminal cases. CNN reported that Trump inflated his net worth by as much as \$3.6 Billion in three separate years. An amazing amount even for Trump; even more may be sought in fines. James would also seek disgorgement—the taking away of Trump's ill-gotten gains. And she would likely seek that restitution be paid to the wronged parties. There would be an injunction against the continual fraud by the Trump organization and its people.
