


Discussion and planning are core to Older Drivers Safety

As the population of drivers aged 65 and older continues to grow, maintaining safe mobility is important. Older Driver Safety Awareness encourages seniors and their families to assess age-related changes and how best to remain safe on the road or choose other kinds of transportation.

Older drivers are considered more susceptible to serious injury and death in a crash. In Kansas, 72 drivers aged 65-99 were involved in a fatal crash in 2022. Another 3,694 were involved in a serious injury or injury crash. According to the National Highway Safety Administration (NHTSA), more older drivers are in fatal crashes on rural roads versus urban roads.

"If you have an older driver in your family, consider having a positive and engaging conversation about driving," said Chris Bortz, Transportation Safety Assistant Bureau Chief for the Kansas Department of Trans-

portation. "These conversations route. should focus on their current driving behaviors and the resources that are available if they need to stop driving."

KDOT and NHTSA recommend older drivers and their families work together to:

• Promote awareness of the impact aging has on driving.

· Understand how medical conditions and prescribed medications can impact physical fitness, reflexes and vision when driving.

· Discuss knowledge on new road designs such as roundabouts, diverging diamonds or other traffic flow changes along

• Plan trips during the day and when traffic is light.

· Work with older drivers to understand new vehicle technology such as lane departure, back up cameras and blind-spot detection.

• Make sure they correctly use headlights at night, and buckle up every trip, every time.

· Assist older drivers who may no longer be able to drive and help them plan for safe mobility by family, friends or public transport.

Insurance Department issues guidance on surplus lines tax reduction

Kansas Commissioner Vicki Schmidt released guidance to insurance companies on how the reduced surplus lines tax rate will be implemented after the 2023 legislature passed a law lowering the surplus lines tax rate from 6% to 3% for tax years 2024 and after.

The new rate of 3% will apply to policies effective on or after January 1,2024, and to any endorsements to those policies. All new and renewal policies effective prior to January 1, 2024, and any subsequent endorsements on those policies will still be taxed at the original rate of 6%.

Examples include:

Example One: The tax rate for a policy with an effective date of 10/01/2023 is 6% of the total gross premium. An additional premium endorsement to this policy with an endorsement effective date of 06/01/2024 is also 6%. If a cancellation takes place with an effective date of 08/01/2024, the credit is 6% of the returned premium.

Example Two: The tax for a policy with an effective date of 01/01/2024 is 3% of the total gross premium. An additional premium endorsement to the policy with an endorsement effective date of 06/01/2024 is also 3%. If a cancellation takes place with an effective date of 08/01/2024, the credit is 3%.

From MSNBC's Lawrence O 'Donnell: That is the mission of an accessory after the fact. An accessory after the fact is trying to prevent the apprehension of criminals; to prevent the punishment of criminals.

Republican House Speaker, Mike Johnson told reporters, last week about his efforts to obscure the faces of the insurrectionists who attacked the US Capitol on January 6, prior to releasing any of the videos which were taken that day.

Mike Johnson wants to stop everyone of those arrests that can still be made, because of an alert citizen makes a call to the FBI. He wants to stop, possibly, hundreds of arrests which could still be made. Mike Johnson has no legal authority to blur the faces of criminals in that video. That video does not belong to Mike Johnson, that video does not belong to the Republican party. That video was created by and paid by the United States Congress. It is owned by the Federal government.

The MSNBC program in which O 'Donnell made his remarks, told of the specific law that House Speaker Johnson had violated; 18 US code \pm 3 - Accessory after the fact that states:

Whosoever, knowing that an offense against the United States, has been committed receives, relieves, comforts, or assists the offender, in order to hinder as to prevent his apprehension, trial, or punishment, is an accessory after the fact."

The Republican House Speaker has hired new workers to blur the faces of the January 6 attackers in order to prevent future arrests by the Department of Justice. Johnson is now an accessory after the fact.

O 'Donnell: That is the first time in history that a Speaker of the House has said that he doesn't want people who committed Federal crimes to be charged by the DOJ.

In the Federal case against the former president, Special Counsel, Jack Smith wrote the following in a Court filing: The defendant has chosen to publicly and vocally support the "January 6 choir," a group of defendants, held at the DC jail, many of whose criminal history and/or crimes on January 6 were so violent that their pretrial release would pose danger to the public. The defendant, Trump, has nevertheless, supported, and celebrated the offenders - many of whom assaulted law enforcement on January 6 - by promoting and playing their recording of the National Anthem at his political rallies and calling these charged inmates at the DC jail "hostages."

Perhaps most importantly, the defendant's embrace of January 6 rioters is evidence of his intent during the charged conspiracies because it shows that these individuals acted as he directed to act, indeed, the evidence shows that the rioters disruption of the certification of the government proceeding is exactly what the defendant intended on January 6.

And finally, evidence of the defendant's statements regarding possible pardons for January 6 offenders, is admissible to help the jury assess the credibility and motives of trial witnesses because through such comments, the defendant is publicly signaling that the law does not apply to those who act at his urging regardless of the legality of their actions."

The defendant's false claims about the 2012 and 2016 elections are admissible because they demonstrate the defendant's common plan of falsely blaming, "Fraud," for election results he does not like, as well as motive, intent and plan to obstruct the certification of the 2020 election results and illegitimately retain power.

"Well, we're going to have

to see what happens." Trump said when asked in 2020 before the election whether he would commit to making sure there is a peaceful transfer of power after the election. We now know what he had plans for after his losing. Trump's inner circle at the White House, January 6 rally organizers, Republican House members and Republican Senators were all in support of doing, whatever in order for Trump to remain as president. They announced Trump's "Big lie" about a rigged or stolen election, whenever they'd appear on news shows. Trump continues to falsely claim that he is the true winner of the 2020 election with zero push back from anyone in Congress.

Everything points to Trump being the one who tried to steal the election victory away from Joe Biden. And his followers still believe Trump! They support a Felon convicted of rape and defamation of character and fined \$10 Million dollars. Trump is under indictment in four jurisdictions with 91 Felony charges. P.S. Former president Donald Trump is not immune from civil lawsuits that blame him for the violent Capitol Hill attack on January 6. That is the ruling handed down from an Appeals Court.
