

# **Social Media Needs Regulation**

Social media is a Jekyll and Hyde phenomenon beneficial in some respects and dangerous in others. On the bright side, these humorous gems were posted before the Super Bowl:

- "On Groundhog Day, Punxsutawney Phil saw his shadow, so we'll have two more weeks of Kelce and Taylor Swift."
- "Thanks to @taylorswift13 for finally making a practical "if a plane leaves Tokyo at 11:30" problem that students will care about."
- "I don't know anything about football, but Taylor Swift must be good because he sounds fast."

Social media keeps us in touch with our friends—its original purpose—and, through them, with their friends and their friends' friends, ad infinitum. Because of how the algorithms work, they also connect us with like-minded persons and organizations around the world, many of them educational. YouTube videos show us how to replace a wall switch or teach us basic organic chemistry.

On the dark side, the Senate Judiciary Committee held a hearing January 31 with the CEOs of Meta (Facebook, Instagram), TikToc, Snap, X, and Discord to discuss the effects of social media on the lives and mental health of young people (The CEO of Google, that owns YouTube, by far the most popular site among teens, did not attend.). From online bullying, sexual predators, unrealistic beauty standards, eating disorders, and suicide to the addictive features built into social media to maximize profits, parents testified to their concerns.

Committee members of both parties clearly agreed about these dangers and

grilled the CEOs about what they are doing to make their sites safe for youngsters. Chairman Dick Durbin (D, Illinois) said social media companies "are responsible for many of the dangers our children face online.... Their design choices, their failure to adequately invest in trust and safety, their constant pursuit of engagement and profit over basic safety have all

put our kids and grandkids at risk."

Senator Lindsey Graham (R, South Carolina) said, "After years of working with [Durbin] and others, I've come to conclude the following: social media companies as they're currently designed and operate are dangerous products....You have blood on your hands." Missouri Senator Josh Hawley (R) asked CEO Mark Zuckerberg if he'd take responsibility for the harm Meta has caused, but Zuckerberg's reply was that his company's job is to "build industry-leading tools" and empower parents. Hawley interrupted with "To make money." Exactly. The bipartisan Kids Online Safety Act has been proposed in the Senate.

The Senate isn't alone in its concern. Forty-one states and D.C. are suing Meta in federal or state courts. The federal complaint claims "Meta has harnessed powerful and unprecedented technologies to entice, engage, and ultimately ensnare youth and teens. Its motive is profit, and in seeking to maximize its financial gains, Meta has repeatedly misled the public about the substantial dangers of its social media plat-



forms. It has concealed the ways in which these platforms exploit and manipulate its most vulnerable consumers: teenagers and children." The states seek damages, restitution, and an end to harmful company practices, and are considering suing other social media, as well.

Social media is not just dangerous to the young. Because it's a news source for millions where anyone can post anything no matter how crazy, it's chock full of "fake news"—rumors, crackpot conspiracy theories, and deliberate lies promoting an agenda, often political. Social media is a misinformation superhighway because its algorithms dramatically magnify misinformation.


Unlike reliable news media, social media has no editors or management legally responsible for protecting young users or for not misleading the public. Government regulation strict enough to stop the harm will require social media platforms to adopt new and possibly less profitable business models. So be it.

And so be this: The Kansas City Chiefs are now a dynasty! Great game by a great team.

Currently I am reading the non-fiction book "The First Migrants" another part of our history that didn't make it into our high school history books. It tells how Black homesteaders' quest for land and freedom heralded America's Great Migration. Beginning in 1877 until 1920, many Black people exercised their rights under the Homestead Act settling in all the Great Plains states. Some created Black homestead communities and others homesteaded alone. Nicodemus, Kansas is the only one still in existence. Authors Richard Edwards and Jacob K Friefield make this a must read in fascinating detail.

Committee Updates

Many of the bad bills being pushed by Republican politicians have something in common: they strip away local control on critical issues facing our communities. Here are some to look out for:

•Blocking protections for LGBTQ Kansans: Republican Senator Mike Thompson introduced a bill to ban counties or cities from passing legislative protections for the LGBTQ+ community. Not only does this bill override the authority of local governments, it also makes our state a less welcoming place.

• The bill to ban plastic bans: Senate Federal and State Affairs held a hearing on a bill blocking local bans on plastic bags. I support local control and the right of communities to enact their own policies. This bill takes away the right of local officials to protect their environment.

• Banning ranked choice voting: Senate Federal and State Affairs held a hearing on a bill to ban the use of any form of ranked-choice voting method for the conduct of elections. I don't support this bill, because it strips away local control from county officials.

Governor Kelly Vetoes the Flat Tax Bill

Last Friday, Governor Laura Kelly vetoed the flat tax bill, House Bill 2284. The bill would benefit the wealthy at the expense of working Kansans: 70% of the tax cuts would go to the top 20% of income earners in Kansas.

On Wednesday, the Senate tax committee held a hearing for Governor Kelly's bipartisan tax proposal that would deliver relief for working families. You can watch Adam Proffitt (Budget Director) explain the proposal here.

Governor Kelly is dead set on making sure Kansans see a tax cut this year. She has said that she'll even call a special session if necessary. I support her veto decision, and I look forward to working with my colleagues on both sides of the aisle to pass tax relief that supports working families.

Kansans Make Their Voices Heard for Medicaid Expansion

On Monday, the Kelly administration announced that since calling for a hearing on the Cutting Healthcare Costs for All Kansans Act, 1,020 Kansans have sent 23,710 emails to legislators to demand the House and Senate hold debates on Medicaid expansion. #### Quotes To Ponder By Tom Valverde

This ruling cuts to the heart of accountability in our system; an imperfect but still not functioning democracy. The people still have the most powerful check on such presidents with their vote.

For the purpose of this criminal

trial, former president Trump has become citizen Trump, with all the defenses of any other criminal defendant. But any executive immunity that may have protected him while he served as president, no longer protects him against this prosecution.

I think that we all understood

that their decision was going to come out this way. The argument coming from Trump's lawyers was so outlandish; this would be a decision against Donald Trump.

The legal ruling is so sweeping and so resounding and so unanimous and clear in its upholding what it means to be a country governed by the rule of law... You have someone who is running to be president to whom a unanimous court said at bottom: "Former President Trump's stance would collapse our system of separated powers by placing the Executive beyond the reach of all three Branches."

Their decision shows that no person is above the law... That criminal statutes should apply to anyone who violates these laws. This is criminal because it's much more than rhetoric. It's a multiprong, intentional plan as we laid out in the Select Committee's report. It was a design to disrupt the transfer of power...It was the combination of the Fake electors, pressure on State election officials and the vice-president; together, this shows intent to disrupt the joint session of Congress."

The case before DC Judge Tanya Chutkan has former president Trump facing four felony charges:

1. Conspiracy to defraud the United States.

2. Conspiracy to obstruct an official proceeding; the certification of the Electoral College ballots by Congress.

3. Conspiracy against the rights; making sure that everyone's vote counts.

Trump attempted, by several means to overturn the 2020 presidential election results and steal the election win from Joe Biden. The unanimous decision by the DC Court of Appeals says that Trump is now a regular citizen and he does not have any sort of presidential immunity. The appeal court wrote in its ruling that the former president actions, "are an unprecedented assault on the structure of our government.

Trump allegedly injected himself into a process in which the president has no roll -- the counting and certifying of the Electoral College votes-- thereby undermining Constitutionally established procedures and the will of Congress...

We cannot accept former

president Trump's claim that a president has unbounded authority to commit crimes that would neutralize the most fundamental check on Executive power -- the recognition and implementation of election results. Nor can we his apparent contentions that the Executive has carte blanche to violate the rights of individual citizens to vote and to have their votes count.

Trump was given just one week to submit an appeal to the Supreme Court. Most legal scholars have said that the Court's ruling is "air-tight" and that it is unlikely that the Supreme Court would take up his appeal.

How such a corrupt man is the leading candidate for the White House by the Republican party is an amazing thing. We must all vote to keep such a person from ever serving as president. Many of his former followers are now convinced that Trump is unfit to be president. It's taken his being charged with 91 felony indictments in four jurisdictions but, it's finally opening some eyes as to the real danger Trump poses for the United States.
