### The red flags of romance scams

Topeka, Kan. – You have a match! The online dating service or app you have been using has finally paid off.

Conversation clicks. They like everything you like. They don't live in Kansas but want to meet in person—although their money is tight and they can't afford a plane ticket. Have you met the one you've been looking for? Or is it something more sinister? Unfortunately, if your newfound flame starts asking for money and you have never met them in person, you could be looking at a romance scam.

"Save yourself the heartbreak and the financial distress by being very cautious when dating online," said Kansas Insurance Commissioner Vicki Schmidt. "Never, ever send money to someone you have only met online—it's that simple."

Fraudsters took \$1.3 billion from romance scam victims in the US in 2022, according to the Federal Trade Commission. Investment and cryptocurrency schemes often marry with

the romance scam when targeting victims. Be mindful of these red flags while dating online:

- They ask you for money. This is the biggest red-flag and is always a part of any romance scam. They may request the payment in cryptocurrency or gift cards. Never send money to anyone you have only communicated with online or by phone.
- They have all the same interests as you. If a dating profile sounds too good to be true, it probably is. Scammers will use your social media profiles to target you and tailor their scheme towards your life interests. Be careful what you share about yourself online.
- They can't meet in-person or even video chat. Scammers may make plans to meet or chat in person but always find an excuse to cancel, often an elaborate one. If you have chatted with someone for months but have never met them in person, they may be a scammer.
- They offer an investment opportunity. "Pig-butchering" is a type of romance scam

where scammers will string victims along promising companionship, only to take their life savings through a fraudulent investment-much like a farmer fattens a pig for slaughter. Be very cautious if your online acquaintance asks you to invest your money.

If you suspect you have been the victim of investment fraud from a romance scam, please contact the Office of the Kansas Securities Commissioner, a division of the Kansas Insurance Department at 785-296-3071 or file a complaint online at insurance.ks.gov/department/ksc/complaint/ksc-complaint.php, and visit SmartInvestKS.com to learn more about different types of investments and how to avoid fraud.

### Increasing Access To **Programs** And **Improving** Service

"We will administer our programs equitably by reducing administrative burdens and reaching underserved people," said Martin O'Malley, Commissioner of Social Security. "In line with the Administration's whole-of-government approach to deliver better outcomes for the American people, I'm pleased to share our Equity Action Plan 2023 Update."

In 2022, SSA released its first Equity Action Plan in accordance with the President's Executive Order, Advancing Racial Equity and Support for Underserved Communities Through the Federal Government.

The updated SSA Equity Action Plan includes several new focus

- Ensure language does not pose barriers to apply for benefits and access services;

### SENATE NEWS

This Week at the Capitol

This week marked the last week for bill introductions. With a few exceptions, as of Friday at 5pm, no more bills can be introduced for the 2024 session. The deadline for bills to pass out of their house of origin, also known as turnaround day, is February 23.

We had many guests in the Capitol this week! On the Senate floor, we honored students from across the state participating in the Jobs for America's Graduates-Kansas (JAG-K) program. The organization partners with public schools, communities and employers to help students overcome challenges and prepare for successful futures.

In Senate education, students from the Kansas State School for the Blind spoke about their educational experiences and increasing access for persons with visual impairments. Senator Pettey had the privilege of meeting with Sloane Anderson and Sarah Burrichter, who are currently receiving services from the school's programs.

On Thursday, Governor Kelly signed the first bipartisan bill of this session to incentivize businesses to pay Kansans with disabilities a fair wage. This bill will strengthen our workforce and give our disability community the opportunities they deserve. I'm proud to support it.

Welcome Rosedale Middle School Pages

I had the privilege of welcoming pages from Rosedale Middle School this week, including Aletse Ortiz Soto, Belen Gracian, Tatiana Rodriguez, Loretta Stueve, Adalyn Bernardino, Alexander Garcia-Arellano, and their teacher, William Heck. The group toured the capital building, including the dome, and went to the Senate session. Thank you for your civic engagement!

In addition to welcoming pages this week, I had the opportunity

to meet with JAG-K students and advisors from Harmon and Schlagle high schools, as well as two students, Sarah Burrichter and Sloane Anderson, who receive services from the Kansas State School for the Blind.

Spotlight on Health

I had the privilege of meeting with various health groups this week, including nurse anesthetists from across the state. Additionally, representatives from the Wyandotte County Health Department, including Kimberly Kern, Elizabeth Groenweghe, and Dustin Hare, were here to give testimony in Public Health and Welfare regarding SB404, expedited partner therapy.

Office of Early Childhood Pro-

posal is Introduced

Governor Kelly announced her bill to consolidate Kansas' early childhood care and education services into a single agency — the Office of Early Childhood. I had the privilege of introducing this bill in Senate Ways and Means this week. This bill consolidates early childhood programs into an existing state agency, the Kansas Children's Cabinet and Trust Fund. and renames the agency to represent its expanded scope. Both Republican and Democrat legislators joined Governor Kelly in supporting the legislation.

We must eliminate the red tape that makes it difficult for families and child care providers to access services. I agree that unifying Kansas' early childhood services will help Kansas families access child care services and ensure they no longer have to navigate the maze that is our current system.

Governor Kelly Announces Nearly \$28M to Create 458 Child Care Slots, Construct New Community Multi-Purpose Facilities

Governor Kelly also announced the creation of 458 new child care slots with the investment of nearly \$28 million in Capital Projects Fund Accelerator awards to seven Kansas communities. These funds will build or renovate multi-purpose community facilities that create new licensed child care slots; provide access to high-speed internet; and house programs that

facilitate work, education, and health care monitoring.

These grants are made possible using American Rescue Plan (ARPA) funding from the U.S. Department of Treasury Capital Projects Fund, which awarded \$40 million to Kansas for this program in early September. These are exciting projects that will improve quality of life, support job seekers, provide innovative resources for continuing education, and improve health outcomes for families!

#### Committee Updates

Unfortunately, several bills intended to incite a culture war rather than address real problems were also introduced this week. Here are some bills to keep an eye on:

More Voter Suppression: Senate Fed & State held a hearing on Senate Bill 365, Republican Senator Mike Thompson's bill requiring all

advance voting ballots be returned by 7:00 p.m. on election day. This is one of many bills introduced by Republican leadership to restrict voting access and further politicize our elections.

Vouchers are back: Once again, a private school voucher proposal has been introduced in the legislature. Senate Bill 469 would divert state funding from public schools and the vast majority of Kansas students who attend them. Pouring taxpayer dollars into private schools will not help Kansas kids, but it will hurt our public schools and communities.

Personhood bill: Senate Judiciary is holding a hearing next week on Senate Bill 425, a bill allowing people to seek child support for a fetus. This is an underhanded attempt to advance an anti-abortion agenda and lay the groundwork for fetal "personhood." I will always fight against efforts to put medical decisions in the hands of politicians.

So it's always nice to have the opportunity to lift up the work that my friends are doing to improve the lives of their constituents. Here are some highlights from this week:

Expanding the Silver Alert Plan: Senate Health Committee held a hearing on Senate Bill 371, Senator Cindy Holscher's bill to expand the Kansas silver alert plan to provide public notice of missing persons 18 years of age or older who have an intellectual disability. This is an effective way to help ensure the safety of our citizens.

Tampon Tax: My colleague Senator Faust-Goudeau introduced Senate Bill 435, which provides a sales tax exemption for period products, diapers and incontinence products. These products are essential and should be recognized as material basic needs rather than luxury goods. Child income tax credit: Senate Bill 436 creates a state child tax credit. Under this bill, families making \$25,000 or less annually would receive a \$600 refundable credit per qualifying child, and the credit amount would decrease as adjusted gross income increases. I agree with my colleague Senator Ethan Corson: Kansas thrives when our families thrive. This bill helps to ensure that all Kansas children have their basic needs met.

Supporting our minority, disadvantaged, disabled veterans: My colleague Senator Faust-Goudeau introduced Senate Bill 464, which creates the Kansas minority, woman, disadvantaged and service-disabled veteran small business enterprise development act. These veterans sacrificed to protect our country and our values. Supporting them is the right thing to do.

Welcoming Taylor and Travis to Kansas. Travis Kelce and Taylor Swift have had a major economic impact on the KC metro area. My colleague Senator Cindy Holscher introduced a resolution welcoming them to Johnson County and thanking them for shining such a positive

light on our state!

#### Moms Demand Action

On Thursday, a large group of volunteers from Moms Demand Action visited the capitol to advocate for gun safety. This group does not advocate taking away gun rights, but exists for the protection of children.

Unauthorized access to guns presents a serious safety risk to children in Kansas. Here are two bills related to gun safety that you should know about:

Secure Storage. My colleague Senator Holscher introduced Senate Bill 137, which would require that a firearm must be securely stored when not under the owner's immediate access and control. This can be achieved by securing the firearm with a trigger lock mechanism or storing the firearm in a locked container. Laws that require proper storage seek to encourage responsible behavior, and hold people accountable, not unduly punish residents. I support this legislation.

Strict Scrutiny. HCR 5020 would amend the state constitution to be more protective of firearm ownership, and codify that any infringement on firearms rights would be subject to a "strict scrutiny" standard in the court. A strict scrutiny standard would threaten to eliminate Kansas's most crucial public safety laws, including prohibitions on gun possession by convicted felons and domestic abusers. This resolution poses a direct threat to Kansas public safety laws that protect our communities by keeping guns out of dangerous hands. I oppose this resolution.
