The event occurs on April 5 & 6 from 8 AM to 12 PM at Indian Springs, 47th & Orville, Kansas City, KS 66102.

Visitors need to show proof of Wyandotte County residency with something displaying their name and address, like a driver's license or utility bill.

Items accepted include electronics recycling, mattresses, furniture, general appliances, fixtures, microwaves, freezers, televisions, and more.

For televisions, computer screens, flat screens, and monitors, the following fees are charged:

- \* CRT Computer Screens, \$40
- \* LCD/Flat Screen TVs, \$20
- \* CRT TVs, \$40

Cash only. Exact change is required. For the complete list of accepted electronics recycling, visit [wycokck.org/DumpsterDays](http://wycokck.org/DumpsterDays).

Items that cannot be accepted include:

- \* All household hazardous waste
- \* Paint
- \* Refrigerators
- \* Yard & storm debris waste
- \* Batteries
- \* Food waste
- \* Medical waste
- \* Glass & plastics recycling
- \* Tires
- \* Construction or demolition material
- \* Any item from businesses, non-profits, or other commercial entities

These items will be turned away at the event, so remember not to bring them!

For yard waste, storm debris, and glass or



paper recycling, residents may use the Recycling & Yard Waste Center at 3241 Park Drive, Kansas City, KS 66102, at no charge. The Recycling & Yard Waste Center is open from 10 AM to 3 PM, Thursday through Saturday, until December 21. The center is closed on holidays.

## Governor Kelly Signs Bipartisan Bill Allowing Private Funds to Support Dolly Parton's Imagination Library



Governor Kelly signed Senate Bill 195, authorizing the Kansas Children's Cabinet to establish a nonprofit corporation to receive donations, gifts, grants, and engage in fundraising activities for Dolly Parton's Imagination Library.

"Strengthening children's literacy skills and ensuring parents can access these resources is crucial to early childhood development," Governor Laura Kelly said. "We know that children's earliest years shape their academic and social outcomes for the rest of their lives. I'm proud to sign this bill to expand the reach of the Dolly Parton Imagination Library and equip more Kansas families with books."

Governor Kelly announced in July that every child aged 0-5 in Kansas is now eligible to participate in the program to receive one free, high-quality, age-appropriate book per month until their fifth birthday. In August, Governor Kelly welcomed Dolly Parton to Kansas to celebrate the statewide expansion of her Imagination Library program.

"Well Kansas, we did it! Let's celebrate by registering as many children and families as we

can to receive the gift of Imagination Library books right to their home each month," said Dolly Parton. "Together, we can inspire children across Kansas to love books and reading, and that's a gift that will last a lifetime."

The statewide expansion was made possible through increased funding provided to the Kansas Children's Cabinet and Trust Fund by Governor Kelly and the Kansas Legislature last year. Allowing private donations to the book gifting program will expand its reach to promote reading in Kansas and positively impact early childhood development and literacy skills.

"The Kansas Children's Cabinet has been delighted to serve as statewide lead for Dolly Parton's Imagination Library. To date, our focus has been on ensuring full statewide coverage

for all Kansas families," said Melissa Rooker, Executive Director of the Kansas Children's Cabinet and Trust Fund. "We are excited to take the next step so that we can fully engage with the private sector and fundraise to ensure the longevity and sustainability of this worthwhile program."

As of March 1, 2024, 74,720 Kansas children are enrolled in the program. Since Governor Kelly announced the statewide expansion of the program last July, nearly 26,000 more children have been enrolled. Parents can enroll children in the Imagination Library of Kansas here.

# SENATE NEWS

## This Week at the Capitol

We have returned to a slower pace in the Capitol, with the bulk of the work happening in committees, where we are considering legislation passed out of the House during the first half of the session.

On Wednesday and Thursday the Senate met to approve three appointments made by Governor Kelly. Two appointments to the Board of Tax Appeals were approved unanimously. Congratulations to Devin Specker and Virginia Powell. Jon Rolph was reappointed to the Board of Regents by a vote of 31-3. During his time on the Board of Regents, Jon Rolph has shown that he has a real understanding of how to position Kansas' higher education system to meet the needs of students, families and businesses. I was proud to vote in support of him! It is unfortunate, however, that the Republican leadership held off on his confirmation for three months, due to his stance on diversity, equity, and inclusion.

## Medicaid Expansion Rally

This week the statehouse was full of Kansans advocating for Medicaid Expansion!

Giving 150,000 Kansans access to affordable health care would save lives and lower health care costs for everyone. It would also be good for the bottom line: Kansans are paying federal taxes to provide health care in other states but not our own. Kansas has already lost out on nearly \$7 billion in federal funds, we shouldn't miss out on any more. And it's extremely popular: over 70% of Kansans – regardless of party – support Medicaid expansion. My office alone has received over

1300 emails in support of Medicaid expansion.

It's past time to do the right thing and expand Medicaid!

**A Major Attack on Voting Rights**  
On Tuesday, Kansas Senate Democrats blocked a major attack on voting rights. Extremist Republicans in the Senate wanted to eliminate the three-day grace period for returning mail-in ballots and instead require all ballots to be received by 7 pm on Election Day.

Kansans heavily relied on vote by mail during the 2020 election, and eliminating the three-day grace period would lead to major voter disenfranchisement. My colleague Senator Mary Ware explained during debate how removing the three-day grace period would create an unne-

cessary barrier for disabled voters who require more time to complete and submit their ballots.

During debate, Republicans amended their bill to make it even worse. These amendments include banning voting machines, blocking the use of secure ballot drop boxes, and requiring costly and inaccurate hand-counting.

Our Secretary of State cannot make it clearer: Kansas elections are safe and secure as they are. There are real problems facing this state, and election security isn't one of them. I voted no on this bill, and I'll continue voting no on attacks to Kansans' fundamental right to vote. This bill failed on a vote of 15-17 with many legislators "passing" instead of voting for or against the bill.

**Rehashing the Flat Tax:** On Tuesday Senate Tax is holding a hearing on Senate Bill 539, Republicans' latest tax proposal. SB 539 includes a flat tax and is a rehash of the proposal that failed last month. Starting in 2024 the individual income tax rate would be 5.7%, and decrease

in following years until it would reach and remain at 5.45% for the year 2029. This proposal also has less tax relief for seniors than Governor Laura Kelly's proposal and Republicans' previous proposal: it does not completely eliminate state Social Security taxes. We should be passing tax cuts that support working families and our seniors. Kansans don't want to see another reckless tax experiment.

GOP leadership is going in the opposite direction on property tax reduction: House Tax on Wednesday at 3:30 is looking at eliminating the Ad Valorem Tax revenue transfer back to local entities with their hearing on HB2815 — Abolishing the local ad valorem tax reduction fund and the county and city revenue sharing fund, discontinuing certain transfers to the special city and county highway funds.

The state continues to cost local units of government, thus our property tax dollars, hundreds of thousands of dollars with revenue-neutral notices. Thursday House Tax looks at HB2795 — Requiring notices required to exceed the revenue neutral rate to be sent on forms provided by the director of accounts and reports, granting taxing subdivisions the option to hold hearings on the same day and at the same location as other taxing subdivisions within a county

More Voter Suppression: On Tuesday Senate Federal and State Affairs will hold a hearing on HB 2512, a bill that reduces mandatory early voting hours. The bill replaces a guaranteed early voting time with a theoretical additional day some counties may utilize, but many are unlikely to. We should be making it easier to vote, not harder. This proposal to reduce early voting hours would take Kansas in the wrong direction.

Governor Kelly Announces

More than \$930M in Highway Projects Added to IKE Development Pipeline

Governor Laura Kelly announced the addition of 17 highway modernization and expansion projects — a total investment of \$932 million — to the Eisenhower Legacy Transportation Program's (IKE) Development Pipeline. IKE is the Kelly administration's bipartisan 10-year, \$10 billion transportation program.

The announcement clears the way for preliminary engineering work to begin on these projects, which are in every region of the state. The projects result from the Kansas Department of Transportation's (KDOT) fall 2023 statewide Local Consult listening tour. More than 1,400 Kansans from across the state participated in these public meetings. Two projects close to home include modernization of both K-5 from U.S. 73 southeast to I-435 in Wyandotte/Leavenworth Counties and I-35/U.S. 56 interchange in Johnson County.

These highway projects tackle long-standing transportation needs across the state — improving safety, expanding economic development opportunities, and strengthening our communities. Governor Kelly's administration is committed to making short- and long-term infrastructure improvements to benefit future generations of Kansans.

From the House Democrats

This week the House Democrats fought hard against HB 2749, a bill requiring medically unnecessary and burdensome abortion reporting requirements. This bill would require providers to ask and report each patients' "reasons" for seeking care from a legislatively defined list of 16 available "reasons" along with other invasive, personal questions.

Rep. Melissa Oropeza offered an amendment that was defeated to require vasectomy patients to answer the same questions as women seeking abortions. Rep. Lindsay Vaughn pointed out that this bill singles out women for intrusive questions that aren't asked of men seeking health care.

HB 2749 stands in direct opposition to the will of Kansans who spoke loud and clear that they did not want politicians in their exam rooms. It's simple: Republican leadership is not listening to Kansans.

Women's History Month

March is Women's History Month and today is International Women's Day! Today I'm especially inspired by my colleagues, our strong, amazing Senate Democratic women who are working hard to empower women and girls across Kansas.

From making sure women have access to the resources they need to enter and remain in the workforce (including high-quality, affordable child care), to fighting to protect women's reproductive freedom, Senate Democrats are committed to creating a more equitable Kansas.

Update on Women's Reproductive Health Legislation

In a House debate on Wednesday, legislators discussed the merits of HB 2749. The bill requires abortion providers to survey women seeking abortions and report information on any abortions performed to the state legislature.

"We just want to have more information. Make sure we're making the right decision for these women," the GOP chairwomen said during the debate. The August 2, 2022, vote on the anti-abortion constitutional amendment made it very clear: Kansans do not want the government making in their most intimate healthcare choices for them. This includes the government throwing obstacles in place and forcing them to tell the government why they were thinking of terminating their pregnancy from a pre-selected list of options.

Governor Laura Kelly echoed the sentiments this week when she said, "Quite honestly, I don't understand it, you know, because I think Kansans made it very, very clear how they want Kansas to

operate in this arena. Why would an elected official who's facing an election in November go against the wishes of their constituents?"

Abortion bills continue: In the House Fed & State committee on Tuesday: HB2809 — Creating the Every Mom Matters Act to require the state treasurer to contract with eligible organizations to provide information and support services to pregnant women and parents considering adoption.
