## Wyandotte County Lake Park Temporarily Closed Until Further Notice Due to Extreme Storm Damage

KANSAS CITY, KS - Please be advised that Wyandotte County Lake Park, located at Leavenworth Road and 91st Street, KCK, KS, is temporarily closed until further notice. This closure is due to severe storm damage that occurred on Sunday, May 19. The overnight storm caused extensive damage, including fallen trees, power lines and significant damage to some of the docks.

The safety of the community is our top priority, and it is important that we take the necessary steps to ensure no harm comes to anyone at Wyandotte County Lake Park. Unified Government staff are actively assessing the damage and developing a plan for repairs and restoration.

We will provide progress updates and will notify the public once Wyandotte County Lake Park is safe to use again.

Have Storm Debris?

Residents have several options for responsibly disposing of branches, shrubs, stumps, and other yard waste.

Kansas City, Kansas, residents can place debris curbside on their normal trash day. Leaves and grass clippings must be bagged and not more than 50 pounds per bag. Tree limbs must be tied in bundles not more than four feet long and less than 50 pounds. Limbs must be 4 inches or less in diameter.



# Kansas Launches Summer EBT Program to Improve Food Access for Kids During Summer Break

TOPEKA - The Kansas Depart- SNAP EBT benefits." ment for Children and Families (DCF) is launching Summer EBT, a new program to help eligible families offset some of the costs of buying food for their schoolaged children over summer break. Summer EBT, also known as SUN Bucks in other states, is a partnership between DCF and the U.S. Department of Agriculture, Food and Nutrition Service. The program provides families \$120 for each eligible school-aged child to buy groceries.

"Summer is a time when many children lose the free and reduced-price meals they get at school and when households might need a little extra help putting meals on the table," said DCF Secretary Laura Howard. "Summer EBT benefits can be used to buy food like fruits, vegetables, meat, whole grains, and dairy at grocery stores, farmers markets, and other places that accept

"Children and teens need healthy food year-round to play, grow, and learn. Summer EBT will help families stretch their grocery budget during the summer and provide their children with the nutrition they need to thrive," Howard continued.

Summer EBT benefits will begin rolling out in mid to late July. For most families, Summer EBT will automatically be added to an existing household's Kansas Benefits Card (also known as an EBT card) or loaded onto a Kansas Benefits Card and mailed to the home. Families that don't receive Summer EBT benefits but believe they qualify must apply between Aug. 12 and

Sept. 11, 2024, through the DCF online self-service portal, dcfapp. kees.ks.gov. Children who receive Summer EBT can still participate in other summer meal programs that may be available in their community.

Eligibility:

Children may be eligible for the program if:

• The child is school-aged (7-17 years old) and received food assistance, Temporary Assistance for Needy Families (TANF), and/ or foster care benefits at any point during the school year.

OR

• The child attends a Kansas school that offers the National

School Lunch or School Breakfast Program, and the household income meets the requirements for free or reduced-price school meals at any point during the school year.

Enrollment:

By the end of July 2024, benefits will be issued automatically to eligible children whom DCF can identify in partnership with the Kansas Department of Education. Any child(ren) who did not receive benefits by the end of July 2024 may apply for Summer EBT benefits through the online self-service portal, dcfapp.kees.ks.gov. Online applications for Summer EBT will be accepted from Aug. 12 through Sept. 11, 2024.

# Contractor fraud costs us all

Topeka, Kan. – This year, many Kansans have hired contractors of different trades to help them recover and rebuild after severe weather. But not every contractor that knocks on your door after a storm is legitimate. The National Insurance Crime Bureau (NICB) estimates that 10 percent of the amount paid by insurers for claims in 2023 was lost to fraudulent contractors, costing not only the homeowner, but every policyholder in the form of increased premiums.

"It is natural for people to want to restore their home or property as fast as possible after a catastrophe," said Kansas Insurance Commissioner Vicki Schmidt. "Too often fly-by-night contractors prey on that pressure

and profit off your misfortune. Be cautious, ask questions, and always check with trusted resources before signing any contract or handing over money."

This week is Contractor Fraud Awareness Week, and the Kansas Department of Insurance and the NICB offer some tips for home and business owners on how to avoid becoming a victim of contractor fraud after a natural disaster:

• Research and verify: Before hiring a contractor, research their credentials, reputation, and track record. Check for licenses, certifications, and reviews from previous clients. Verify their insurance coverage and inquire about any past complaints or legal issues.

• Get multiple quotes: Obtain bids from multiple contractors for a price comparison. Be wary of significantly low bids, as they may indicate substandard work or hidden costs. Seek out a licensed, insured, and well-reviewed contractor before any potential fraudulent contractors come knocking on your door.

• Beware of red flags: Be on alert for red flags such as high-pressure sales tactics, vague or evasive answers, or reluctance to provide written estimates or contracts. Review the contract carefully, ensuring that all terms and conditions are clearly outlined and agreed upon by both parties. Be wary of signing an assignment of benefits on your claim, as this gives a contractor full authority to negotiate and make decisions with the insurance company without you.

Roofing contractors in Kansas must register with the Kansas Attorney General, and a list of registered roofers can be found at InYourCornerKansas.org. **Final Budget Passes** 

Last week, the House Committee on Appropriations and the Senate Committee on Ways and Means met to discuss omnibus items. The omnibus budget bill is a large bill that comes after the overall budget bill to tie up loose ends before the Legislature adjourns. I am glad to share that the Legislature passed a strong overall budget. Here are just a few highlights:

\* Makes critical investments in water projects and programs: The budget continues the state's historic \$35 million yearly investment in water infrastructure, conservation, and quality programs across Kansas. It also pledges an additional \$10 million specifically for drinking and wastewater infrastructure projects in communities of less than 1,000. This funding will be essential to ensuring our small, rural communities have access to a clean and reliable water supply for years to come.

\* Strengths economic development opportunities: The budget includes economic development projects that invest in communities in every region of the state. It also invests in industrial park projects, the infrastructure that is needed to get products to market, and moderate-income housing. These are key to attracting the jobs and workforce needed for communities looking to grow.

\* Ensures Kansas has a robust workforce and increases funding for post-secondary education: Provides historic funding to workforce training programs and post-secondary education to prepare students to enter the workforce for good-paying, in-demand jobs. When looking to put down roots or expand operations, businesses are looking for states that have a high-skilled, well-prepared workforce. \* Invests in state employees: Provides pay raises to state employees to make state employment wages more competitive to the equivalent private sector work. Competitive wages are a step toward shrinking the number of unfilled state jobs and retaining employees.

\* Funds special education: The bipartisan budget for K-12 public education includes a \$75 million increase in special education funding. Funding special education ensures that all Kansas students have access to the resources they need to be successful.

Despite these successes, this budget falls short in a few areas:

\* Playing politics with the border crisis: The Senate voted 28-11 to override the governor's veto of a portion of the budget that allocates \$15 million to send National Guard troops to the Texas border. This is wrong and unconstitutional: border security is a federal issue, and it is not the Legislature's role to direct the operations or call out the National Guard.

\*Funding for an Anti-Abortion Program: The Senate voted 28-11 to override the governor's veto of abortion of the budget that allocates \$2 million for the State Treasurer to continue an "Alternatives to Abortion" program. The Legislature should listen to Kansans and stop inserting themselves in private medical decisions between women and their doctors. Special Session Anticipated Kansans need meaningful sales, property, and income tax relief. However, we must ensure that the plan is affordable for the long term.

This week, the Senate sustained a veto on HB 2036 and called on Republican leadership to introduce a tax bill that is fiscally responsible while offering fair relief to all Kansans. Instead, they sent yet another plan to the floor that they knew was dead on arrival because of its lack of fiscal responsibility.

From the beginning, Governor Kelly has committed to calling a special session if necessary to make sure Kansans see a tax cut

New Online Portal from KC Board of Public Utilities

The Kansas City Board of Public Utilities (BPU) has launched a new online customer portal: MyMeter.

MyMeter allows customers to continue to manage their account online while providing a more modern, user-friendly look and feel. Customers will be able to track their energy and water usage down to the minute, compare their usage with weather patterns, and set up personalized alerts. With MyMeter, customers can also personalize their home screen with customized widgets to quickly get the information that matters to them. All of this helpful information will help customers save energy, save water, and save money.

Customers will have to register for a new online account in order to access the new customer portal. Although customers will lose access to their old online accounts, their new MyMeter account is preloaded with past energy usage, water usage and previous bills to ensure customers will not miss a beat.

Customers who are enrolled in scheduled payments with BPU will have their accounts migrated to MyMeter, and will simply need to reset their passwords in the new system to log in. Scheduled payments will not be interrupted for customers.

# Year-round tax planning pointers for taxpayers Here are some simple things taxpayers can

Here are some simple things taxpayers can do throughout the year to make filing season less stressful.

Organize tax records. Create a system that keeps all important information together. Taxpayers can use a software program for electronic recordkeeping or store paper documents in clearly labeled folders. They should add tax records to their files as they receive them. Organized records will make tax return preparation easier and may help taxpayers discover overlooked deductions or credits.

Identify filing status. A taxpayer's filing status determines their filing requirements, standard deduction, eligibility for certain credits and the correct amount of tax they should pay. If more than one filing status applies to a taxpayer, they can get help choosing the best one for their tax situation with the IRS's Interactive Tax Assistant, What Is My Filing Status. Changes in family life — marriage, divorce, birth and death — may affect a person's tax situation, including their filing status and eligibility for certain tax credits and deductions.

Understand adjusted gross income (AGI). AGI and tax rate are important factors in figuring taxes. AGI is the taxpayer's income from all sources minus any adjustments. Generally, the higher a taxpayer's AGI, the higher their tax rate and the more tax they pay. Tax planning can include making changes during the year that lower a taxpayer's AGI.

Check withholding. Since federal taxes operate on a pay-as-you-go basis, taxpayers need to pay most of their tax as they earn income. Taxpayers should check that they're withholding enough from their pay to cover their taxes owed, especially if their personal or financial situations change during the year. To check withholding, taxpayers can use the IRS Withholding Estimator. If they want to change their tax withholding, taxpayers should provide their employer with an updated Form W-4.

Make address and name changes. Taxpayers should notify the United States Postal Service, employers and the IRS of any address change. To officially change a mailing address with the IRS, taxpayers must compete Form 8822, Change of Address, and mail it to the correct address for their area. For detailed instructions, see page 2 of the form. Report any name change to the Social Security Administration. Making these changes as soon as possible will help make filing their tax return easier.

Save for retirement. Saving for retirement can also lower a taxpayer's AGI. Certain contributions to a retirement plan at work and to a traditional IRA may also reduce taxable income.
